GOVERNMENT ASSISTANCE

Better Jobs Ontario

If you're laid off or unemployed, Second Career Ontario can help you transition to a new career. It covers up to \$28,000 of education and living costs. To apply to Second Career Ontario, find an agency in your community and make an appointment. The agent will help inform you of the information needed to support your application to Second Career Ontario.

Work BC

WorkBC Centres support you in finding a job and keeping it. Services are available to all unemployed or precariously employed B.C. citizens legally eligible to work in B.C. GOVERNMENT ASSISTANCE (CONTINUED)

Canada Student Grants

When you apply for a [Canada Student Loan](#), through your province or territory of residence, you will also be automatically considered for a Canada Student Grant.

Canada Training Credit

Individuals at least 26 years old and less than 66 years old at the end of the year can accumulate \$250 in their Canada training credit (CTC) for the next year.

Canada Job Grant

Every province/territory has a Canada Job Grant program for employers to help pay for employee training. Research Canada-[Province] Job Grant for more information, e.g.: Canada-B.C. Job Grant.

Canada Council For The Arts Funds

The Digital Strategy Fund helps artists, groups, and organizations understand the digital world.

Canada Education Savings Grant

The Canada Education Savings Grant is money that the government adds to a Registered Education Savings Plan. This money helps cover the cost of a child's studies at [designated](#) educational institutions.

WSIB Ontario

WSIB Ontario provides wage-loss benefits, medical coverage, and support to help people get back to work after a work-related injury or illness.

BANK ACCOUNTS

Student Lines of Credit

Most banks (either yours or as a first-time customer) offer student lines of credit to help cover tuition costs and living expenses. For prospective Ontario and Quebec students, [Caisse Desjardins des Technologies de l'information](#) offers a preferred rate. Inform our admissions team during the application process if you're interested in accessing these funds.

Registered Education Savings Plans/Registered Retirement Savings Plan/Lifelong Learning Plan

Full-time bootcamps *and* part-time courses at Lighthouse Labs are eligible for RESP withdrawal. Full-time programs *only* are eligible for RRSP/LLP withdrawal. Ask us for a letter of confirmation during enrolment and we'll provide you with the proper documentation to provide your financial provider.

TAX CREDITS

T2202 tax credit forms are issued for **all** programs for cohorts delivered in the **previous** year.

First Nations Tech Council

The Bridging to Technology program provides BC Indigenous youth with comprehensive wrap-around training and services they need to pursue specialized training in a technical field.

Women Learn to Code & Take Leadership encourages the emerging generation of young women to consider a career in Tech. Through our introductory part-time courses and the Web Development Bootcamp, participants learn the skills to start their careers as developers.

Canadian Armed Forces
